The principles and teachings of Freemasonry are first presented to those joining Mosaic Lodge through the three degrees of Symbolic Masonry and thereafter by educational programs, numerous self-study resources, and by witnessing how other Masons practice them in their daily lives. The sixty-four members of the Lodge were provided with a variety of opportunities for Masonic fellowship and growth. Members were informed about Lodge meetings, degree work, and various activities and were encouraged to participate whenever possible. Some of the activities included family members.

Charitable Assistance: To provide funds and other assistance to individuals and/or organizations for religious, charitable, scientific, literary, and educational purposes

Charity is one of the fundamental principles of Freemasonry and is evidenced through its financial support of a variety of worthwhile causes. In 2014 Mosaic Lodge awarded grants totaling \$13,950 to ten qualified non-profit organizations and awarded \$2,000 scholarships to five outstanding high school seniors in order to assist them in pursuing a post-secondary education. The Lodge also awarded a \$500 grant to a young handicapped individual to help make it possible to purchase a lift device enabling him to be lifted into and out of his bed. Masonic charity, however, goes beyond that of financial assistance and is evident through its members acts of kindness and service to those in need of assistance whether they be Masons or not.

Mosaic Lodge has developed a comprehensive application process to be followed by non-profit organizations applying for grants and by students applying for scholarships to be awarded by the Lodge. Firsthand knowledge is required of members or other individuals needing charitable assistance and must be supported by bills or other documents. If approved by the Lodge, checks are issued directly to non-profit organizations awarded grants, to institutions of higher learning for students awarded scholarships, and to those businesses which are owed funds by a member or other individual needing charitable assistance. Since most of the non-profit organizations awarded grants are local, the Lodge has the ability to monitor their implementation. A number of non-profit organizations have presented, prior to Lodge meetings, programs describing how the funds granted were used. Most grants awarded outside the local area were for Masonic organizations for which the Lodge is very familiar with how the funds granted were used. Students selected to receive scholarships generally write to the Lodge expressing their appreciation and occasionally write follow-up letters indicating how the scholarships helped them during their first year at the institution of higher learning they are attending.

Part VI, Section A, Lines 1, 6, & 7: Mosaic Lodge is classified as a subordinate organization operating under a central organization, the Grand Lodge of Iowa, A.F. and A.M. The Grand Lodge, through its Constitution and Laws for Subordinate Lodges, specifies how subordinate lodges are to operate including their form of governance. Any man, who has received the three degrees of Symbolic Masonry in a particular lodge or any Mason who has affiliated with it, is classified as a member of that lodge with the right to vote on all matters which may come before it. The Grand Lodge specifies that all members of a lodge present at a regular meeting of that lodge, provided that a quorum of seven is present, are entitled to vote and thus make governance decisions on behalf of the lodge. The Grand Lodge does not authorize delegating this authority to a smaller body. Thus the sixty-four members of Mosaic Lodge form its governing body.

Part VI, Section A, Line 8: As required by the Grand Lodge, the secretary of a lodge records the minutes of every regular and special meeting of the lodge in a minutes book which is kept for an indefinite period with most being kept from the time that the lodge was chartered by the Grand Lodge. During a regular meeting of Mosaic Lodge, various committees will give a verbal report of their activities, if any. These reports are entered into the minutes of that meeting. Any recommendations made by a committee must be voted upon by the members of the Lodge present at a regular meeting.

Part VI, Section B, Line 11: The data for Form 990 is initially prepared by the Treasurer of Mosaic Lodge and then given to a C.P.A. firm for review and preparation. The Treasurer reviews the completed Form 990 at a regular meeting of the Lodge -- the members present constituting the governing body. Upon request, any member of the Lodge may examine Form 990 in detail.

Part VI, Section B, Line 15 & Part VII, Section A, Column F: As a small token of appreciation for their service, Mosaic Lodge provides for the annual payment of honorariums to three of its officers -- the Master, Treasurer, and Secretary. These honorariums; \$75, \$150, and \$300 respectively; are determined by tradition and the Lodge's By-Laws. An amendment to the By-Laws would be required to change the amounts specified therein. The current amounts have been in effect since 2001.
