The Foundation, with advice from their CPA as needed, continually evaluates expiring statutes of limitations, changes in tax law and new authoritative rulings in determining if there are unreasonable tax positions subject to the provisions of FASB Interpretation No. 48 when preparing their annual 990. At December 31, 2014, the Foundation has determined that there were no unreasonable tax positions whereby a liability would need to be recorded.
