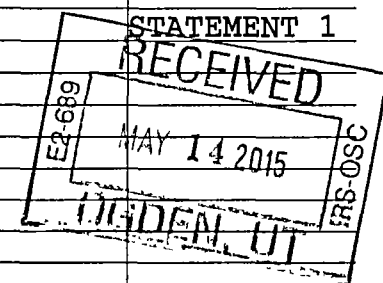



The JSM Charitable Trust (the "Trust") qualified as a private foundation described in Internal Revenue Code section 170(b)(1)(F)(ii) for calendar 2014. All contributions of cash and property received by the Trust in 2014 were redistributed by the Trust in 2014 (and within thirty days after receipt thereof by the Trust) as "qualifying distributions" (as defined in section 4942(g) without regard to paragraph (3) thereof). In this connection, (i) in accordance with Reg. § 1.170A-9(g)(2)(iv) and (v), in some cases the Trust has elected to treat the fair market value of the contributed property at the date of its distribution by the Trust to the public charity (rather than the date of its contribution to the Trust) as the fair market value of such property for purposes of the requirements of section 170(b)(1)(F)(ii); and (ii) in accordance with Reg. § 53.4942(a)-3(d)(2), the Trust is treating calendar 2014 qualifying distributions in the amount of \$14,382,291 (or such greater amount as may be required to qualify under section 170(b)(1)(F)(ii) for calendar 2014, including through the application of excess qualifying distribution carryovers from prior years if necessary pursuant to Reg. § 53.4942(a)-3(c)(2)(iv)), as distributions out of the Trust's corpus in accordance with section 4942(h).
