RLC provides clinical and pastoral counseling, fosters and cares for church pastors and their families and provides Spiritual Direction teaching, training and mentoring to both church leaders and individuals. During the calendar year 2014 RLC provided 4458 counseling visits. This does not include all of the students and participants in our marriage, bible institute and transforming lives classes. RLC provided \$235,676 in donating counseling services to those otherwise unable to pay.

RLC had 4458 counseling visits in 2014 and of those visits RLC provided \$235,676 in donated counseling services to those who could not afford to pay or could only pay at a reduced rate based upon our sliding fee scale. RLC continues to see a great need in the Las Vegas valley for counseling for both individuals and families. The stresses of daily life, family, marriage and economic challenges continue to present themselves in the clients we see. RLC has partnered with several care groups in the Las Vegas valley such as the Rescue Mission who comes alongside those who are homeless and have drug and alcohol challenges. RLC has played an instrumental role in saving marriages and families during 2014 through ongoing counseling efforts.

In an effort to to foster unity among the Las Vegas valley churches and their leaders, RLC hosted internationally known author, speaker, director and teacher, William Barry. RLC also continues to provide counseling to Pastors in the Las Vegas valley.
