It was important to include the LIHTC units in our mix of senior preferred apartments so that we could offer quality senior housing options in our community that were affordable. Williston has seen very large increases in market rate apartments in recent years due to the Bakken oil development. Bethel Foundation has kept our senior preferred apartments (including market rate) very affordable to our tenants. Many of the tenants we serve in our apartments would have been served by the nursing facility in the 1950, 60 & 70's. At that time there were no other options for seniors in our community other than Bethel Lutheran Home. Today more of these seniors are able to remain independent and un-institutionalized longer because of the senior living apartments.
