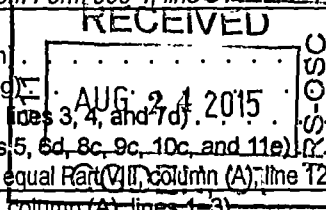

4a (Code:) (Expenses \$ 126,826 including grants of \$) (Revenue \$ 91,038) GYMNASTICS PROGRAM - we provide strength, flexibility, fitness and gymnastic skill classes to ages from 15 months to adult. We provide a variety of classes that vary from one day per week to team levels who practice up to 12 hours per week. Classes run 12 months per year. The objective of the recreational classes is to promote fitness and learning in a fun and safe atmosphere and to build the self-esteem of all that enter our program. The objective of our team program is to prepare youth to compete against others in the USA gymnastics program as well as the High School program while building youth up into well rounded individuals who can handle pressure gracefully.

4b (Code:) (Expenses \$ 14,867 including grants of \$) (Revenue \$ 21,103) SCHOOL (GYM-N-LEARN) PROGRAM - This is a licensed childcare program consisting of our Nursery School, After School & Summer Camp classes. These classes are offered up to 5 days per week for approximately 3 hours per day. Our Nursery School classes are where children ages 2 1/2 to 5 years can learn the alphabet, colors, numbers & shapes. We have planned activities that focus on both academics & learning through: play, stories, crafts, games, letter sheets, music & more. We also learn about nutrition & fitness. In each class they have a snack, 50 minutes of gymnastics or fitness & the rest is academic learning & learning through play time. We focus on having fun & preparing for Kindergarten. Our After School classes are offered to any child that is in pre-school through 5th grade. We provide a caring environment where children receive homework help, reading time, art activities, snack & open gym time. Summer Camp is held during the summer school break (June-August). It runs up to 5 days per week & up to 10 hours per day & includes gymnastics, snacks, games, crafts & more.

4c (Code:) (Expenses \$ 363 including grants of \$) (Revenue \$ 1,003) CAMPS - These was a Spring drop-off in March that ran for 1 day for 8 hours - there were 7 participants. There was one Gymnastics Camp in August which ran for 4 days and 10 hours per day - there were 7 participants.
