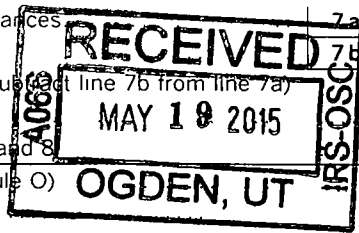

In 2008, the homeless population in Southern California reached an all time high. On any given night, the homeless count for youth in Los Angeles county is anywhere from 5,000 to 10,000. What can be done to stop the cycle of young people adding to this statistic? There are several factors that have contributed to this epidemic. But what factor has the most correlation with youth homelessness?

In a survey conducted with over 200 homeless youth across the state, many revealed having been homeless or in an unclean, unsafe environment for more than 5 years. (Voices From the Street., Bernstein & Foster , 2008). So now one must ask, "Is there a way to reduce the amount of time a young person spends on the street?" Our program focuses on yielding long-term results in a relatively short period of time. The journey to adulthood can be a scary one, but with the right support, it will feel less intimidating.
