IN 2014, WE SERVED AN AVERAGE OF 680 INDIVIDUALS EACH MONTH TRANSLATING TO OVER 122,200 MEALS AND ALMOST 8,000 TOTAL PEOPLE SERVED. MOST OF THE HOUSEHOLDS WE HELPED HAD SOMEONE WORKING FOR WAGE (65%) BUT THEY SIMPLY DIDN'T EARN ENOUGH TO MAKE ENDS MEET. THE REST WERE PEOPLE WITH DISABILITIES, SENIOR CITIZENS ON FIXED INCOMES, AND FOLKS WHO HAD FALLEN ON TOUGH TIMES OR WERE TEMPORARILY UNEMPLOYED. ALMOST HALF (47%) OF THOSE BPNN HELPED FEED IN 2014 WERE CHILDREN.
