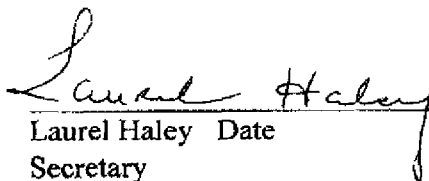

Our animal adoption program has continued to have success. We were able to rescue many organisms from various local schools and take care of them until other schools requested the animals for their science units.

Overall, it was a very successful year and we're looking forward to the transition in order to get the financial resources we require to continue our mission.
