VALIDITY OF ACTIONS INVOLVING CONFLICTS

NO ACTION OR TRANSACTION OF THE CORPORATION IN WHICH ONE OR MORE OF ITS DIRECTORS, OFFICERS, OR EMPLOYEES HAS AN ACTUAL OR POTENTIAL CONFLICT OF INTEREST SHALL BE EITHER VOID OR VOIDABLE FOR THIS REASON ALONE OF BY REASON ALONE THAT SUCH DIRECTOR(S) OR OFFICER(S) ARE PRESENT AT THE MEETING OF THE BOARD WHICH AUTHORIZES THE ACTION OR TRANSACTION, PROVIDED THAT THE MATERIALS FACTS AS TO SUCH DIRECTOR OR OFFICER'S INTEREST IN SUCH ACTION OR TRANSACTION WERE DISCLOSED TO THE BOARD PRIOR TO THE VOTE AND THE TRANSACTION WAS APPROVED BY A VOTE SUFFICIENT FOR SUCH PURPOSE WITHOUT COUNTING THE VOTE OR VOTES OF ANY INTERESTED DIRECTOR. INTERESTED DIRECTORS MAY BE COUNTED IN DETERMINING THE PRESENCE OF A QUORUM AT A MEETING OF THE BOARD WHICH AUTHORIZES SUCH CONTRACT OR TRANSACTION. AT THE TIME OF THE DISCUSSION AND DECISION CONCERNING THE AUTHORIZATION OF SUCH CONTRACT OR TRANSACTION, THE INTERESTED DIRECTOR OR OFFICER SHOULD NOT BE PRESENT AT THE MEETING.
