Born This Way Foundation transformed its successful Born Brave Bus into the Born Brave Experience, working with partners including Westfield Malls and Facebook to continue providing safe spaces for young people in their communities The Born Brave Experience allowed BTWF to leverage and expand its coalition building efforts and strengthen its relationships with local and national organizations with a shared mission of supporting youth wellness and empowerment The Born Brave Experience encompassed partnerships with 20 local organizations including Active Minds, Youth First, Eye to Eye and Sun Serve Youth, facilitating outreach at more than a dozen stops

Born This Way Foundation expanded its staffing footprint, allowing the foundation to lay the groundwork for key future initiatives, such as the Emotion Revolution with Yale University (held in 2015), and programming for young people, such as the Born Brave Retreat Held in August 2014 in partnership with Camp Hi-Rock YMCA in Massachusetts, the retreat brought together 29 young people ages 14 to 18 to empower them with tools to enhance their ability to advocate for themselves and their peers The campers utilized a curriculum, created by the Human Power Project, that taught them how to manage mental wellness, understand coping mechanisms, increase online safety and share their personal stories
