Our Advocacy program continued to increase public awareness of the dilemma of chronic pain and the disease of addiction promoting alternative, non-narcotic methods for the treatment of pain and advocating for increased access to evidence-based addiction treatment. In 2014 we produced a video about how the over-prescribing of painkillers can lead to addiction and overdose death. Our staff and volunteers advocated for changes in public policy focused on bringing an end to our nation's epidemic of addiction and overdose deaths. We developed coalitions and partnerships to increase the impact of our lobbying and advocacy. We coordinated the 2014 FED UPI Rally in Washington, DC, assembling more than 2,000 people on the Mall to hear expert testimony on the epidemic, and marching to the White House with photos of our lost loved ones. Expenses shown are exclusive of \$18,386 of donated legal services related to these programs.

Our Overdose Prevention program ensured the unanimous passage in 2014 of Good Samantan and Naloxone legislation (Steve's Law) in Minnesota. The legislation provides limited immunity to those who call 911 in good faith to save a life and allows first responders, law enforcement and trained lay people to administer naloxone, which can counteract the effects of an opioid overdose within minutes. Since passage of the law, we have worked to make naloxone available to those at risk of an overdose and to ensure access to treatment following an overdose. We have worked to support other states in their efforts to pass similar Good Samaritan and Naloxone legislation.

4c

Our Prescriber Education program, in partnership with the Minnesota Medical Association (MMA) and the University of Minnesota Medical School, has created Continuing Medical Education (CME) on the subjects of pain management and addiction. Experts in these fields are presenting lectures to the medical students which are then filmed, edited and posted on the website of the MMA as free, enduring CME available to practicing physicians and other prescribers across the country. The lectures provide education on the responsible use of opioids, and on alternative methods to treat pain education that is still lacking in most medical schools across the country. We have created a curriculum that is balanced, practical, evidence-based, and free of commercial bias. We are providing training for prescribers in the safe and appropriate use of naloxone, the benign, life saving drug, which can counteract the effects of an opioid overdose within minutes. Expenses shown are exclusive of \$15,734 of donated legal services related to these programs.
