PART III – STATEMENT OF PROGRAM SERVICE ACCOMPLISHMENT

28. NicaPhoto After School Program serves approximately 100 children and young people living in some of the poorest barrios in Nicaragua. The goal of the program is to provide the proper supports to increase school graduation rates. In 2014 NicaPhoto had a 100% elementary school graduation rate, and increase from the 89% rate of the two previous years and well above the country average of less than 50%. The program expenses of \$37,037 include 90% of Nicaraguan Salaries.

29. Scholarships are provided for public school, private school and university students. Scholarships are base on need. Scholarships are given to make education accessible to even the most disadvantaged children and young people. In 2014 we added a small sports scholarship for exceptional athletes to encourage them to continue both their studies and their athletic persuits. The program expenses of \$10,372 include 10% of Nicaraguan Salaries.
