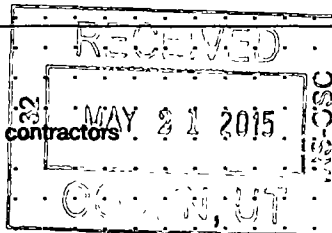

**Part 1, Line 8. Other Revenue.** OceanElders received \$250,000 from the Ted Turner Foundation as a donation to an Arctic Expedition which is to take place in June 2016, focused on conservation and protection of the Arctic. Proceeds were collected in December 2014 and are expected to be paid to the operator of the expedition (Lindblad Enterprises) before December 2015.

**Part 2, Line 24. Other Assets.** The \$250,000 donation described above is being held as a CD.

**Part 3, Line 31. Same asset described above.**

**Part 3, Lines 28-32.** No expenses are listed as all work is done via volunteers and most correspondence is done through email and internet based phone calls, so mailing and other costs are minimal.
