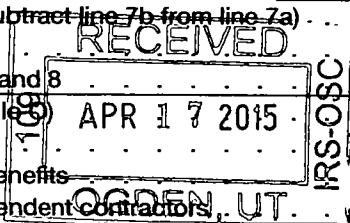

**PART III - STATEMENT OF PROGRAM SERVICE ACCOMPLISHMENTS**

This organization has engaged in activities necessary for the construction and production of a non-profit, non-commercial Christian radio station. The broadcast reaches not only to the initial target counties of Bath, Fleming, and Rowan, but into at least 16 other Kentucky counties as well-a potential listening audience of 300,000. Daily programming of twenty-three hours of classic Christian music and one hour of family interest/community news encourages family values and a proper relationship with God. Management and operation of the station are performed by dedicated volunteers, and promotion and fundraising are achieved through personal contact, email, newsletter, newspaper, and other means of public awareness.
