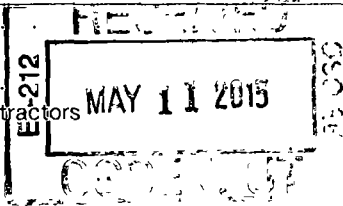

The major accomplishments of 2014 include the opening of an additional home for victims over 18 years of age, as well as collaborating with various rescue groups and receiving a high population of indigenous victims from 3 different regions of Mexico.

Immigration project

The purpose of the immigration project is to identify human trafficking victims from other countries that I have been detained in the immigration detention center in Mexico City. Many of the women and girls who travel to Mexico from other central American countries become, or have already been victims of trafficking. El Pozo de Vida collaborates with the detention center and sends a group of professionals to develop relationships with detained immigrants and provides education and prevention workshops, therapy and counseling. The project also trains immigration officials to identify signs of human trafficking and how to report it. All identified victims are reported to the director of the immigration center. In 2014, the project worked with over 600 women and over 300 adolescents, and 5 human trafficking victims were identified and reported, as well as over 170 victims of other crimes.
