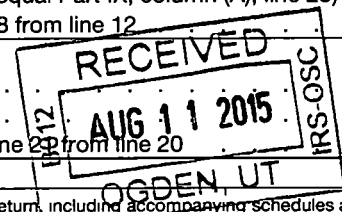

Currently, while a transitioning service member or veteran may have an "advocate" in each organization they may be seeking support, they do not have an advocate across all organizations. The SCOUT is the main point of contact between the client and our partner organizations facilitating and coordinating assistance to a wide range of requests received from service members, veterans and their families. SCOUTs interact with non-profit, faith based, community based, industry, private sector, administrative and government agencies by acting as facilitators, ombudsmen and, in some cases, advocates. The SCOUT establishes an Individual Action Plan (IAP) with each client to ensure a full continuum of support is reached through consistent support throughout each milestone established on the IAP. SCOUTs may also be tasked to attend veteran related events and participate in outreach when necessary.

In 2014, RallyPoint/6 (RP/6) was able to move forward from fundraising in 2013, to opening the center in mid-2014. RP/6 received the occupancy permit for the building, enabling a soft opening in March of 2014 and Grand Opening - September of 2014.

The initial 2013 donations from private foundations and corporate sponsors to establish and open RP/6 enabled the build out of a first-class, military-community facility that serves as a safe, reliable and welcoming place for service members, veterans and their families to seek a number of resources including: employment, education, benefits, family stability, financial & legal, housing and volunteerism opportunities as they transition to their next objective. The 2013 funds raised supported the development and implementation of 2014 operations supporting the
