ALTHOUGH THE WARS IN AFGHANISTAN AND IRAQ HAVE BEEN RAGING SINCE 2001 AND 2003, RESPECTIVELY, THE DEPARTMENT OF DEFENSE AND THE VETERANS ADMINISTRATION HAVE JUST RECENTLY BEGUN TO ADDRESS THE SIGNATURE WOUND OF THESE CONFLICTS, TRAUMATIC BRAIN INJURY (TBI). THERE ARE AN ESTIMATED 20% OF OUR RETURNING MILITARY MEMBERS AND VETERANS WHO SUFFER FROM THESE WOUNDS, A STAGGERING 300,000. IT IS ALSO ESTIMATED THAT ONLY 30% OF THESE VETERANS ARE DIAGNOSED AND FOLLOWED AT VA HOSPITALS, CURRENTLY. SINCE THE PRIVATE HEALTH CARE SECTOR REPRESENTS 99% OF THE RESOURCES REQUIRED FOR TBI REHABILITATION, IT IS IMPERATIVE THAT WE INCREASE AWARENESS OF THIS DEVASTATIVE WAR RELATED INJURY AND BEGIN TO PROVIDE MORE ACCURATE DIAGNOSIS AND TREATMENT. OUR AWARENESS PROGRAM

YET, IT IS AN INJURY AFFECTING NEARLY 300,000 MILITARY MEMBERS AND VETERANS AND CURRENTLY LACKS PROPER DIAGNOSTIC PROTOCOLS.
