Vision for Children, Inc. works in the poorest section of Chile, La Pintana. In this community, only 30% graduate high school and the area is rampant with gangs, violent crime, prostitution, child abuse and child neglect. The courts routinely take children from their families due to abuse and neglect and place them into group homes called Hogars (which we would refer to as orphanages). We work through an organization we caused to be founded in Chile, Vision for Children - Chile which is formally recognized by the government of Chile as a non-profit. Through this, we run the House of Hope which assists young ladies who are too old to live in the hogars or in extreme poverty to complete high school and to work towards obtaining an advanced degree. In 2014 alone we have one young lady become a beautician and another a practical nurse. Another girl left the program with a high school diploma and one-year left in a nursing program. We also assist local schools, hogars and neighborhood children in English, band, choir, art and other programs designed to keep them out of gangs and into school. We send Mission Work Teams and Interns to Chile several times a year to help in these programs and to do construction of facilities to enhance our assistance. In 2014, a woman lost her home and two children to arson and we were able to build and give to her a temporary house. Some 500 children and young adults were supported in 2014.

Vision for Children, Inc. has been asked why we do not assist in the US. In 2014, a five-unit apartment building was donated in Kingston, NY. This is close to an orphanage for boys. This apartment was to be renovated to be used as a House of Hope to assist those orphans too old for the orphanage to continue their education. Contractors and engineers were consulted to determine what repairs needed to be performed to first bring the building into compliance with the City of Kingston and secondly to modify it to be used as a House of Hope. Rather than approve our applications for building permits to bring the building into compliance, Kingston caused the building and all improvements to be razed. The expenses in 2014 were engineering and municipal expenses in obtaining and modifying the structure. Expenses include a \$95,000 expense due to the loss of the existing building. During 2014, no one was helped in this program. A new building will have to be constructed prior to commencing operations in New York.

Part I 2. Vision for Children, Inc. caused a non-profit to be formed in Chile which is called Vision for Children - Chile. It is approved by the government in Chile to work with abused and poor in La Pintana, Chile. Each month we are issued a report of the activities and quarterly a financial report. The Executive Directors of each organization hold regular conference calls. Missions trips are held several times each year at which time the Executive Director and other officers travel to Chile to work.

These program services include support for the House of Hope that provides a home and/or assists with obtaining high school diploma, university, technical school or life skills training for abused and poor young women. It also includes providing assistance to hogars (homes for children taken away from their families due to abuse or neglect) and local schools. The graduation rate from high school is only 30%. We have programs to teach band, chorus, Bible Training and other training to attempt to keep children out of gangs and off drugs and remain in school. These programs are supported by Missions Teams and Interns from the United States as well as the girls living at the House of Hope and volunteers from those living in Chile.

Part I 16 During 2014 a 5-unit apartment building was donated. This apartment building was to be modified to become a House of Hope to support orphans from local orphanages in New York in obtaining higher education. An appraisal done in 2012 indicated that the value of the apartment building in its current condition was \$100,000. A structural engineer and a building contractor examined the building and determined that it was structurally sound and repairable. An inventory and evaluation of the building indicated \$90,000 in salvage value for antique fixtures, new unused high efficiency furnaces, new unused high efficiency hot water heater, timbers and flooring. The City of Kingston caused the building to be razed which decreased the value to \$5,000 for property. The 2012 appraisal of the property is being used to set the value at time of donation.
