

Expenses related to inspiring dancers to become more civically engaged global citizens through university chapters, international dance exchanges, and year-round dance programs in underserved communities: insurance (\$2500), supplies (\$2431), lodging and meals (\$11237), dance education and development (\$1898), banking (\$138), website (\$166), transport (\$16417), and other (\$1089).

Movement Exchange has expanded its impact substantially in the latter part of 2014. Movement Exchange's chapter network doubled in size and new partnerships with domestic violence shelters, youth foundations, and orphanages were formed. The Movement Exchange university chapter network donated over 460 hours of dance education during Fall semester in the United States. Movement Exchange continues to fund weekly dance classes in three orphanages in Panama where 100+ children receive free arts education. University of California at Irvine and Indiana University both recently returned from an exchange in Panama, and one of their dance diplomats had the following to report,

"I can honestly say that this has been the most rewarding experience as both a dancer and a person. I had the opportunity to share my own passion of dance, and was learning from others and the culture of Panama at the same time. I strongly believe that dance is something that we all love and can relate with, and watching what we accomplished with very little verbal communication is proof of the power of dance. We didn't give toys or other material objects. We gave the gift of self-empowerment, movement and love."

Movement Exchange is currently featured in an upcoming dance documentary highlighting how dance plays a role in cross-cultural understanding.

Our first research trips to India also took place in the last five months in order to better solidify partnerships and plan for the upcoming Movement

Exchange to Mumbai and Kolkata in January 2015. Movement Exchange will also support 2 foundation's dance programs in India year-round.
