Civic Engagement: We worked with tribal colleges, tribal governments and other Native organizations (based in both reservation and urban locations) throughout the state of Montana to educate Native citizens about the electoral process and the importance of civic engagement at all levels, from local school boards up to national offices and issues.
We conducted an aggressive outreach program in 2014, including presentations at major pow wows and tribal colleges on Montana reservations. We provided our members with information on how to get involved in their communities, participate in public policy decisions, interact effectively with decision makers, and develop leadership skills necessary to create positive social change.

4b (Code:) (Expenses \$ 77,961 including grants of \$) (Revenue \$)
Voter Rights: Western Native Voice was a founding member and steering committee partner in a statewide ballot initiative aimed at defeating proposed legislation that would limit voter access and participation across Montana. Rural, underserved regions, including reservations, would have been most significantly impacted by the proposed legislation. We conducted a door-to-door canvass to educate voters about the proposed legislation. We also distributed free information, both in print and in digital form to Native citizens.
We identified lack of access to polling stations as a significant impediment to many Native voters. We are working with federal, state, and tribal agencies to expand access through satellite voting stations, two satellite stations were established in 2014 and we are working to have at least two more in place before the 2016 elections.

Advocacy: We worked with members and tribal leaders across Montana to advocate for expansion of the Medicaid program as suggested in the Affordable Care Act.
We worked with tribal leaders to advocate for preservation of Native language and culture, including maintaining funding for the Indian Education For All program and for tribal colleges. We collaborated with community leaders and elected officials to protect tribal sovereignty.
