

- 1 All assets (whether or not considered an improvement, betterment, restoration, or adaption of a unit of property) or expenditures for material and supplies of \$500 or less per item, will be recorded as an expense on our annual financial statements or in our accounting records or books when paid or incurred
- 2 This includes any and all assets, whether leased, leasehold improvements, financed, or purchased in full
- 3 The threshold amount above will be measured on a per item, per invoice basis
- 4 This policy does not apply to purchases for land, inventory, or any expenditure that we elect to capitalize and depreciate
- 5 Definitions and other considerations
 - (a) Tangible Property- refers to all tangible personal and real property acquired or produced by the company as implements, tools, materials, supplies, equipment, furniture, land, buildings, or fixtures for the purpose of carrying out all aspects of business operations
 - (b) Repair – amounts necessary to maintain the property in an ordinary, efficient, operating condition. The cost of the repair does not add to the value or prolong the life of the asset
 - (c) Improvements – expenditures for additions, alterations and renovations that appreciably prolong the life of the asset, materially increase its value, or adapt it to a different use
 - (d) Routine maintenance – includes the inspection, cleaning and testing of the unit of property and the replacement of damaged and worn parts with comparable and commercially available and reasonable replacement parts
