In addition to workshops and seminars LUVI provided 52 youth with opportunities to work with local businesses during a ten-week program. The Summer Youth Employment Program (SYEP) provides eligible youth with age-appropriate job training, life skills, counseling, work-readiness skills and supervised meaningful work experience. This program presents an opportunity to connect youth to the skills that are needed to enter and advance in the workforce.

Students from the 2013 Holiday Wreath of LUV Program sold customized holiday wreaths with fresh pine and ornaments. Through their business concept course, they developed a model allowing them to raise thousands of dollars for LUVI.
