• The Accountability Incubator program identified 9 "Accountapreneurs" in Liberia and Nepal in 2014, and provided them with hands-on training, mentoring, seed funding, networks, and management support to develop and implement a low-cost, high-impact idea strengthening integrity in their community. Their projects included:

1. A film school in Liberia to train young people how to make documentaries about accountability issues in their communities. The school trained 40 young filmmakers, and conducted film festivals and community screenings to disseminate student-made films. During the Ebola

crisis, they created films on preventing spread of the virus and overcoming stigma for survivors, bringing life-saving information to

thousands of people across Liberia.

2. A civic education program that trains Nepali students to be active citizens, through political debates, art competitions, constitution drafting, interactive games, government office visits, and community services projects. 270 students in 4 schools participated in the program, and school administration and Ministry of Education officials were exposed to new ideas.

3. A wiki site called "Nalibeli" that crowdsources step-by-step instructions on how to access government services in Nepal -- including registering a business, applying to a university, selling land, obtaining a passport, filing a complaint, and more. The site has received more than 270,000 hits, and has saved citizens substantial time, money, and hardship.

The Lab trained the accountpreneurs as change-makers in their community, and collectively these accountpreneurs engaged over 184,561 citizens on accountability.

• Accountability Lab's Outreach and Partnerships focuses on creating global discussion about critical accountability issues, raising awareness about innovative tools citizens can use to hold their power-holders accountable, and building a spirit of collective action.

Highlights in 2014 included:

1. Integrity Idol TV show in Nepal to empower citizens to nominate and vote for the most honest civil servants, which received over 1 million views;

2. Partnering with the ONE Campaign to host the Honesty Oscars awards, in which 91,000 people voted for the best anti-corruption media around the world; and

3. Founding the OpenGov hub in Kathmandu to serve as a co-working/community space for organizations working on transparency. We also hosted panel discussions and other community building events, conducted accountability trainings, led Social Impact Tours in Nepal, presented at conferences and forums, served as key media correspondents on the role of accountability in the Ebola crisis, ran an accountability-themed blog, and reached an audience of over 2 million on social media.

• The Accountability Ambassadors program found passionate civil society leaders in countries in South Asia and Sub-Saharan Africa (Pakistan, Afghanistan and Zimbabwe) to serve as ambassadors for anti-corruption and integrity. These ambassadors identified key accountability issues in their community and gaps in the efforts to solve them. Then, they hosted community-building events, conducted advocacy campaigns, and built relationships with creative change-makers to lay the foundation for running an Accountability Incubator in their country. For example, our Pakistan Ambassador hosted a launch event for the community to learn about Accountability Lab and a round-table discussion about accountability with lawyers and media representatives; began planning for an Accountability Film School in Islamabad, and wrote blogs on his key learnings.
