FROM ITS INCEPTION, THE FUND HAS GENERATED APPROXIMATELY \$72 MILLION IN CONTRIBUTIONS AND PLEDGES IN SUPPORT OF A VARIETY OF CHARITABLE AND EDUCATIONAL INITIATIVES IN THE CITY OF CHICAGO.
