Education - Equip future birth parents and influencers with reliable content and resources In addition to marketing efforts, the ongoing work of BraveLove involves creating, curating and distributing content through various communication channels BraveLove publishes new content on BraveLove org (weekly), featuring new content via email (monthly), and pushing new or curated content on social media (daily) The development of an Adoption Resource Kit project began in 2014, which is intended as an educational tool for those serving women in unplanned pregnancies It is slated for completion in 2015
