2015 CHNA indicated Heart Disease is the leading cause of death for Pottawatomie County, with 242 3/10,000 compared to the national averag e of 190 1 In addition, O klahoma ranked 49th worst in the nation for lack of physical act ivity at 31% (as reported by the 2011 State of the State's Health Report) Heart Disease a lone accounts for over \$90 million a year in medical cost for Pottawatomie County and is t he number one cause of death for all ages Not only has the hospital provided medical care and treatment of patients with heart disease, there has been a focus on education to reco gnize symptoms of heart attack, as well as care for prevention of heart disease St Anthon y Shawnee Hospital will strive to increase educational initiatives and opportunities for h eart disease awareness, In 2014, educational opportunities were the focus for the importan ce placed on "movement" as a positive term versus the sometimes negative connotation of "e xercise" with emphasis in everyday life This was seen in the February Heart Month awarene ss as well as the development of the first annual walk/run and educational expo for employ ees and the community * Goal sponsor the first ever employee/community walk/run, 65 regi stered participants in the 5K Harvest Health Hustle and 5 in the family walk * Goal Reduc e the readmissions rate for Congestive Heart Failure (CHF) patients, established a baselin e percentage of 22% and developed a program for a follow-up clinic that will see patients within five business days of discharge to supplement current discharge phone calls The St Anthony Shawnee 2012 -
