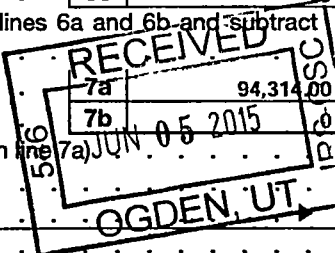

After receiving exempt status the corporation filed Forms 990EZ for 2012 and 2013 and submitted Forms 1120X claiming refunds for income taxes paid. The \$5,772.00 is a net figure since \$5,930.00 was paid and a refund of \$158.26 was received due to a math error.
