SJC's Removal Defense Initiative is one of the few in the nation. It provides removal defense legal services for all low-income individuals in the Bay Area who have some form of relief available to them. The program utilizes staff attorneys to screens eligible candidates, both in immigration detention and out for potential relief, bond opportunities, defenses to deportation, and then provides high-quality defense from start to finish. Staff attorneys at SJC have sole responsibility to manage removal caseloads, attend immigration hearings and work directly with clients and their families. Removal defense includes victims of crimes, unaccompanied minors, appeals and other forms of relief in removal
