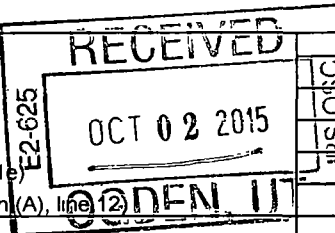

FOLLOWING THE MERGER, WE ADOPTED THE DBA NAME OF BLACK HILLS RAPIDS SOCCER CLUB TO RECOGNIZE OUR NEW AFFILIATION WITH THE COLORADO RAPIDS MLS TEAM AS AN ADIDAS ALLIANCE PARTNER. THIS AFFILIATION PROVIDES TRAINING AND CURRICULUM TO OUR CLUB FROM THE COLORADO RAPIDS. THE BLACK HILLS RAPIDS NOW SERVES APPROXIMATELY 1,600 PLAYERS FROM AGES 5 THROUGH 18. THE BLACK HILLS RAPIDS HELD ONE OUTDOOR TOURNAMENT DURING IT'S FIRST FEW MONTHS OF OPERATION.
