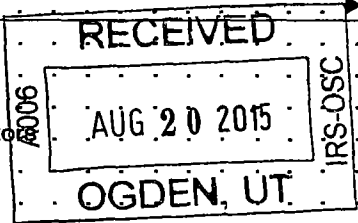

Line28: Spence Mountain Trail System –Multi-Year Project

Payments for surveying the first phase (ten miles) of new trail system in Klamath County, Oregon and cutting three miles of trail.

Benefit: a) immediate– use of trails by 100+ walkers, hikers, bikers

b) long term—upon completion there will be a new 50 mile scenic trail system for hikers, bikers, walkers. Level of 1,000+ users predicted during the season with additional potential for snowshoeing and cross country skiing in winter.

Line29: Two Year Bike Corrals (Bike Parking) Project

Payments for manufacturing of three bike corrals for placement in downtown Klamath Falls. Purpose of project is to promote and support a biking environment , with a long term goal of increasing healthy activities for the populace.

Benefit: a) immediate –opening of three corrals with 54 bike parking spots in downtown Klamath Falls

b) long term – completed project will have four bike corrals (72 spots) in downtown Klamath Falls. In addition to expanding healthy biking options (including downtown trails) for the population, the new bike friendly profile allows the city and the county to participate in and host “bike recreation” events at the local and state levels.
