 Kellogg grant - multi-year grant for 2014 - 2015. The W.K. Kellogg Foundation awarded the Laguna Community Foundation a grant in the amount \$ 50,000 for the Grant Period of May 1, 2014 through April 30, 2015, to enhance Laguna Community Foundation's capacity by strengthening administrative functions and supporting the creation of a fund development plan.

The Laguna Community Foundation began the development plan during 2014 and identified a source for the funds for the development fund. The Foundation will receive an \$ 1.5 million contribution from the Laguna Tribe which will enable the Foundation to deliver programs and services as described in the Mission Statement.

4b (Code:) (Expenses \$ 30,000 including grants of \$ 30,000) (Revenue \$)
 The Laguna Community Foundation has begun to bring our community together to develop a Laguna Language Policy for Tribal Council consideration. Funded initially by a grant from the Indian Education Division of the New Mexico Public Education Department, we are engaging the entire community in facilitated conversations regarding language loss to develop a long term plan to sustain our language for generations to come.

Together we hope to find sensible and sensitive ways to creatively utilize the technologies that we use every day to help us teach, learn and experience our beautiful Keres language.

4c (Code:) (Expenses \$ 116,174 including grants of \$ 161,044) (Revenue \$)
 The Pueblo of Laguna provided the Laguna Community Foundation with a grant for 2014 to continue the development and capacity building of the programs and services that the Foundation is striving to provide as stated in the Mission Statement.
 The Foundation was able to obtain equipment and supplies for administrative purposes enabling the soliciting of additional grant to operate the Foundation. The grant funds from the Pueblo of Laguna were expended on Executive Director salary, equipment, and administrative functions for the Foundation. This grant enabled the Foundation to develop a proposal for a Development Fund that was successful and will be funded by the Pueblo of Laguna over the coming years.
