New American voter engagement: We conduct voter registration at naturalization ceremonies to provide new Americans with the opportunity to become registered voters. WE provide translators at candidate and issue forums so that language is not a barrier to their understanding and education on our voting system and issues important to the community.

Election Administration: we provide election protection monitors during the election to ensure there are no undue barriers or obstacles to voters' ability to cast their ballot.
