ON THEIR OWN. WE RECEIVED 110 VEHICLES. 42 VEHICLES WERE REFURBISHED AND GIVEN TO CLIENTS. 61 VEHICLES WERE SOLD FOR SCRAP, OR TO INDIVIDUALS TO PROVIDE OPERATING CAPITAL. 189 CARS ALREADY OWNED BY CLIENTS WERE REPAIRED TO A SAFE OPERATING CONDITION.
