

Schedule L, Part II, number 1-The organization received a total of 2505.74 in loans from the Chief Administrator for operations. There is a written agreement with the board that these loans will not be paid back until the organization is financially solvent which is projected to occur by the end of fiscal year 2015. Per the agreement no interest will be charged to the organization. The loans include \$1168.91 for equipment (a laptop, a desktop computer, and a file cabinet.) \$1230 for licensure fees including 950 for 1023 application, 20 incorporation fee, 200 for Michigan Bureau of Children and Adult Licensing application for child placing agency, 60 for finger printing fees for the Chief Administrator. Finally, there was \$106.83 for advertising fees including 34.03 for brochures, 43.80 for post office fees, and 29 dollars for web hosting service. All of this together equals \$2505.74 in loans for year 2014.

Form 990 EZ, Part I, Questions 15-21: The organization had no incoming revenue as we pursue licensure and state contract. Therefore, operating costs incurred were paid by the Chief Administrator(an employee). These loans (as explained in Schedule L) totaling \$2505.74 will be repaid without interest at a time when the organization (ODAS) is financially solvent which is projected to be the end of fiscal year 2015. \$106.83 of these loans are listed on Part I, line 15, the other \$2398.91 are added to line 16(additional expenses). The remaining \$17000 listed in line part I, line 16(additional exp) is 2014 salary owed to the Chief Administrator(52 weeks X 10 hours per week @\$30 per hour=\$15000) and the Social Service Supervisor (4 weeks worked X 20 hours per week@\$25 per hour=\$2000). Like the loans these wages will be deferred until the organization if financially solvent. It is projected that this will be at the end of fiscal year 2015. However, the board and the employees have agreed that these will not be paid in a lump sum but in payments not beginning until the beginning of fiscal year 2017. The board and the employees have also agreed that there will be no interest paid on this deferral. The organization will also incur medicare, social security, unemployment, and workers compensation fees at the time the wages are paid but this is not figured in the amount listed in questions 16,18,26 or 27. Based on the agreement between the board and employees it is projected that the organization can operate at a loss while still fulfilling our charitable purpose. We project a contract with the state of Michigan in 2015 and financial reimbursement for completed adoptions that will eventually erase the loss and allow us to be self sufficient.
