Construction. This year we made progress on the House of Mercy Children's Home in Nairobi, Kenya. This home takes in orphaned and abandoned children. We finished railings and roofing of the second floor. When completed, this will allow for 30 more children to be taken off the streets. Also, preschool classrooms can be made from the space available on the lower level.

Orphan care. This year we provided food, clothing, school fees, medical care, shelter, caregivers, and tutoring to over 130 orphaned or abandoned children in Kenya and Sri Lanka.

Missionary activities and pastoral training. This year we provided practical and classroom training for 15 part-time missionaries. They preached in churches, held conferences, taught children, worked with orphans and learned about the problems of poverty. We supported several other missionaries by providing for their transportation to the country where they will be working. We funded a Pastoral training program in Naivasha, Kenya, that counsels and trains over 100 pastors from the region, uniting them in the cause to spread the Christian Faith throughout the world and strengthen them to fight the terrorist movement that has moved into the region with greater force.
