The Challenge Fund was launched in 2014 to inspire charitable giving in the region and help nonprofit organizations leverage giving by offering an up to 1:2 match for contributions made during selected sponsored events/appeals up to a match ceiling. In 2014, the Foundation partnered with 15 nonprofit organizations, raising and returning \$1.38 million to charitable causes.

The Health Fund was established to further the impact of the Paso del Norte Health Foundation as it promotes health and prevents disease in the region through leadership in health education, research, and advocacy.
