

Proposed Board Resolution

Subject: Extension of Initial Board Terms

WHEREAS, Section 3.3 of the Bylaws of the Corporation provides for the manner of election or appointment and term of office of the Directors of the Corporation;

WHEREAS, the Board of Directors believes it to be in the best interests of the Corporation to consider amending Section 3.3 of the Bylaws to provide for a Board rotation schedule that addresses more effectively than the current provisions matters of continuity of Board service and other matters intended to promote the efficient operation of the Corporation with minimal disruption due to the potential rotation of large numbers of Directors;

NOW, THEREFORE, BE IT RESOLVED that, effective July 1, 2014, the terms of the Directors of the Corporation that were initially set to expire on June 30, 2014 and June 30, 2015 be extended until December 31, 2015;

FURTHER RESOLVED, that the Executive Director is hereby authorized to draft for Board consideration such proposed Bylaw amendments as she deems necessary or appropriate to implement a Board rotation schedule reflecting the extension of the original terms as set forth above, and providing for a term rotation schedule beginning on December 31, 2015 such that no more than approximately one third of Board members will rotate off the Board of Directors at any one time.
