The organization identifies displaced refugees of war and famine, who are not being adequately served, and partner with local and international organizations to provide relief to Syrian refugees in Jordan, Iraq and Lebanon. WAM organizes relief efforts with other organizations to provide food, water, medical assistance, transportation, clothing and shelter.

In 2014, WAM coordinated and paid for the shipment of 10 (40 foot) containers of medicines, medical supplies, food, winter clothing, diapers, shoes, hygiene kits and blankets, which were donations collected by other organizations, and valued at over five million dollars.

Each container provides direct assistance to approximately 600 families with average of 6 people in each family. The 10 containers sent in 2014 could have potentially assisted 36,000 individuals in need at a cost of \$4 each.

WAM advocates on behalf of Women's Syrian Handicraft Project, to encourage the purchase of these handicrafts and to foster economic sustainability to the Syrian refugee women.

In 2014, WAM provided a \$1400 grant to support the "Needle and Thread Project", which was created to support internally displaced Syrian mothers to sell their handicraft items to help support their families. As a result of this income generating project, 70 women have been empowered and are productive in contributing to meet some of their children's essential needs, rather than becoming dependent on meager charity donations.

70 Refugee women were assisted at a cost of approximately \$20 each.

Due to the WFP's suspension of the food program to the refugees effective December 2014, WAM donated to five partner agencies in Lebanon and Arbil Kurdistan the amount of \$80,000 in cash grants so the agencies could purchase local food and winterization items, in addition to distributing the Gifts-In-Kind mentioned in 4a) above.

In 2014, Approximately 660 families, totalling 3960 individuals were fed through this food program for approximately \$20 per person.
