The National Partnership's State Network Project focuses on improving the built environment and advancing policy change, with an emphasis on serving lower-income communities. The project operates in seven states around the country (CA, FL, MS, NC, NJ, OH, TN) and also provides information to supporters around the country through webinars and publications. Over the course of the project, the National Partnership has helped ensure the obligation of tens of millions of federal dollars for Safe Routes to School initiatives, engaged hundreds of partners in advancing built environment change, and secured policies and agreements to create safer environments for children walking, bicycling and being physically active.

4b (Code:) (Expenses \$ 503,880. including grants of \$ 173,943.) (Revenue \$)

The National Partnership operates the Fire Up Your Feet program, which allows parents, school personnel and other individuals to access materials to help them become more physically active, track activity levels, win incentive awards for PTAs, and carry out healthy fundraisers for schools and parent-teacher associations. Thus far, more than 1800 schools have registered and there are 60,000 individual users with 17,000 visitors to the website each month. 65% of users report that the program has helped them increase levels of physical activity.

The National Partnership's Regional Network Project focuses on building relationships, coalitions and action plans to inform, organize and capitalize on opportunities to guide policy change and leverage funding for Safe Routes to School and active transportation. The initiative operates in five selected markets around the country (Washington, DC; Pacific Northwest; Northern California; Southern California and Atlanta, GA). This project has helped create demand for Safe Routes to School initiatives and advance active transportation policies and funding streams within the targeted regions.
