	Portal continued its work helping people create pathways out of poverty in Nepal. The organization completed construction of a small workshop in which we developed, tested, and refined our cargo bicycle. With the help of four employees who Portal trained in welding, bicycle manufacturing and mechanics, the Portal Cargo Bike was prototyped and placed with three unique user groups. The first was a family that used the bicycle to pick up raw materials for sale in their business. Prior to having a bicycle, they had to spend money on a rickshaw or taxi to transport these materials. The bicycle has allowed them to save money that can be applied to their business, their family, and their children's education. The second group was a bicycle courier service in Kathmandu. They were able to hire more employees (in a country with an unemployment rate of 46%) and serve a broader clientele with an eco-friendly form of transportation. Finally, we put a cargo bike in the hands of a child's home. Prior to having a bicycle, they would take six trips into town each day to collect food for the children. Now with a Portal Cargo Bike, they are able to gather everything in just one trip! In addition, they are able to transport the children to school, doctors appointments, etc. more quickly on the back of the bicycle. Looking to expand this life-changing impact, we conducted interviews with 200 potential Portal Entrepreneurs. We began distributing Portal Cargo Bicycles to some of these entrepreneurs as part of a trial program. We were encouraged to see them begin to build and grow their businesses with the benefit of the Portal Cargo bike. Feedback was incredibly positive and demand for new bicycles was significant. In September, Portal participated in a large bicycle trade-show, Interbike, where we connected with many amazing people in the cycling industry. One group, GSD Global has offered their services on a pro-bono basis to help us bring the Portal Cargo Bike to market at large scale. As one of the premier design firms in the cycling industry with extensive experience in bicycle design and supply-chain management, GSD is an incredible partner to have as we work to make a difference around the world. Finally, a large website re-build preceded Interbike and this new site was met with rave reviews. The rebuild was done with images taken by a professional photographer who donated her services and paid to come out to Nepal and document our organization. The new site effectively tells our story and demonstrates how we are working to help people turn bicycles into opportunities that create pathways out of poverty.
