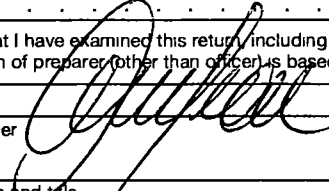

The program includes children from 18 months to five years of age and their caregivers. Its primary purpose is to allow families to reconnect with nature and disconnect with their electronic devices. Children and their caregivers participate in gardening, hiking and campfire activities. They have outings to farms where they are able to have direct contact with farm animals. They learn about the flora and fauna native to Florida in natural and classroom settings. The program includes at least two hours per week of these activities.

Early Education Co-op program:

This program creates a micro-community for caregivers and their children. It provides an environment that fosters friendships between the children and solidarity and support between caregivers. It allows caregivers the opportunity to lean on each other in difficult times.

Caregivers spend quality time with their little ones in an environment that fosters the Conscious Discipline method of parenting.

Children are encouraged to learn through play, socialization and hands-on games instead of from a screen. Many classes take place

outside so families spend 8-12 hours per week in nature.
