 Spring into Reading is a free program offered for ages 3 to 5. It happens seasonally for 4 to 6 weeks per season. Each one hour session includes games, stories, and worksheets that introduce early literary concepts. The group also gives kids a chance to engage with other children. Funds restricted for this program have come from donations. Teachers are then able to submit receipts and be reimbursed for the cost of materials if they would wish. No one wanted to be reimbursed this year, however. All teachers and helpers are volunteers.

 SOBO Project was formed in order to fight human trafficking. Most of our activities this year were raising awareness. We passed out flyers at an Easter Egg Hunt. We chatted with other businesses and churches about trafficking. We formed a task force. We ran a free professionalism workshop for youth towards our larger goal of having a youth center open on the weekends. And our big raising awareness event was a 5K that we hosted in November 2014. People were able to run and have sponsors sponsor their run or walk. As part of the SOBO Project, we also received donations totaling \$140 that are designated for mailing info. These funds have not yet been spent.
