We received General Operating grant funds to assist us in the overall work of organizing, advocating for, and empowering low wage workers.

Our mission is to create systemic meaningful changes in the lives of low wage workers and minorities who face challenges of poverty and oppressive conditions. We help to educate, train, and provide leadership development among workers so that they are able to take action for their own economic and political change. We support workers efforts to organize to win better working conditions, wages, and basic, organizing rights. In 2014 we were members of a statewide coalition to raise the minimum wage. This campaign was successful and in raising the minimum wage has improved the lived fr over 365,000 low wage workers and their families.

Grant funds recieved has now allowed us to hire on two staff organizers and open/maintain an office space to continue our work in 2014.

Hiring staff has allowed us to expand our organizing efforts, began to build a membership base, and develop strong relationships with other community organizations.

990 EZ LINE 29

In late 2014 our organization was provided a grant opportunity to engage members in our community to participate in the 2014 elections.

We were operating totally nonpartisan. Our sole objective was to get people registered to vote, advised them of where they could find info, helped locate their polling place, and get them connected to the process. To carry out the requirements of this grant we hired two temporary staff organizers. Through door knocking efforts, presentations, and tabling at events we were able to engage with over 400 community members. We registered 69 new voters and on Election Day provided rides to 21 people who needed transportation to their polling place.

This grant opportunity also allowed us to build a base for our organization and provided some initial funding for our office site and supplies. 70% of the individuals we connected with during the campaign were low wage workers and/or people of color.

990 EZ Part IV**Additional comments on employee status**

Alisha Williams and Ahmed Ali were originally temporary employees hired on in September for our Voter registration drive they were employed temporarily from September-November 5th. In December they were both hired on as permanent staff. Hours noted on the 990EZ are from temporary and permanent employment of staff in late 2014, not the entire year.
