North by West organized a four day film festival in Portland, OR to explore and celebrate Irish history and culture and the Irish-American experience in the Pacific Northwest. Films included The Wind that Shakes the Barley, Bloody Sunday, The Secret of Roan Inish, and Brave. The event included community discussion around issues of culture, history, family heritage, and assimilation. About 200 people participated. We spent more money than we made on this event.

4b (Code: 813319) (Expenses \$ 1150 including grants of \$ 0) (Revenue \$ 23795)
The event was called "Black History, Black Future." It took place in Oakland, CA, to educate about the civil rights struggle of African-Americans and celebrate the culture of the Black community in the bay area. There were lectures/performances by historian-story teller Diane Fertatte and jazz musician Amande King. The acclaimed Oakland Youth Chorus performed. Two films were screened, Soundtracks for a Revolution and Freedom Riders. There was personal testimony from elders who participated in these historic events, and engaging discussion afterward. Over 1,000 people participated throughout the day and evening.

4c (Code: 813319) (Expenses \$ 1050 including grants of \$ 0) (Revenue \$ 11827)
Feminist Forward! A Celebration of Women was a full day event focusing on violence against women and the possibilities for change. The Red Window Project presented on the realities of human trafficking in the bay area and stories of women's struggles to exit prostitution and reclaim their lives. Advocates from Freedom House talked about their work ending male violence. Storyteller Ellen Augustine performed stories of inspiring + courageous women. Historian Max Dashu gave an impressive lecture on the global history of women's rights. The bay area YWCA presented on models of social change to address sexual violence. The evening was a screening of the film Half the Sky. The event inspired participants to get involved with the groups that presented. Over 1,000 attended over the course of the day.
