The University of Vermont Nursing and Health Sciences Practice Group launched in February 2014 with staffing services provided to one assisted living facility. Within six months, the organization opened Appletree Bay Primary Care, a nurse practitioner primary care practice in Burlington, Vermont. This kind of practice is unique to the area and one of only a few within Vermont.
