HNC Living Foundation received their IRS Determination Letter in July 2014 retroactive to December 31, 2013 While waiting to hear the results of their request for nonprofit status, the Board met together with advisory members to discuss topics critical to the startup of an organization intent on successfully fulfilling its mission locally and nationally Board members generously donated time and funding An Executive Director was hired in June 2014 Contact with similar organizations on a national level was made, work on developing policies and procedures for funding needs of head and neck cancer patients and the organizations that served them progressed, an Advisory Board and Medical Advisory Board were created by an amendment to the By-Laws with advisory members approved to serve, an Endowment Fund was established, and an Endowment Fund Policy put into place The HNC Living Foundation website was designed and launched on September 10, 2014 Head and neck cancer was promoted at the Kansas City Royals baseball game on September 12, 2014 The organization formed a committee to begin planning the Foundation's first fundraising event, Masks for Aid, to be held in April 2015 to coincide with Head and Neck Cancer Awareness Month During 2014, a grant request was approved to fund a specialized massage table for lymphedema therapy (treatment for fluid retention and tissue swelling, often causing severe fatigue and heavy swollen limbs) for head and neck cancer patients treated at the University of Kansas Cancer Center Funds were also forwarded to a locally-based nonprofit, Cancer Action, to support their direct assistance program for head and neck cancer patients
