Together with global partners and governments, OneReef will replicate our model to help communities protect 20% of all coral reefs in the Micronesia Region. In 2014, OneReef initiated development of our model in an additional 10 Communities in Palau, FSM and the Republic of the Marshall Islands (RMI). We supported the development of initial Marine Conservation Agreements with reef owners to lay groundwork for future partnerships. OneReef also provided enforcement infrastructure, sustainable financing, and enforcement training for communities. We partnered with the national governments of Palau and FSM, as well as local organizations to support these activities.
