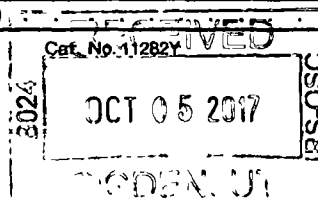

TheatreLAB has chosen live performance as our artistic medium because of its immediacy, its immersiveness, and its inherent ability to build community through shared experience. In order to continue developing and expanding the Richmond Theatre audience base, we believe that patrons should be continually offered high-quality performance art, and arts organizations should strive to produce events that appeal to audiences outside of their own. TheatreLAB produced one shows for the period beginning September 29, 2014 and ending December 31, 2014, running for six to seven weeks. TheatreLAB estimates that this one show sold a total of approximately 1,200 seats, of the estimated 1,300 available to sell.
