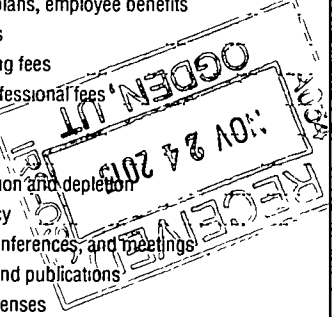

The purpose of the TimkenSteel Charitable Fund (the "Fund") is to improve through charitable giving the quality of life in the communities where TimkenSteel associates live and work. The following are general guidelines for grant applicants seeking grants from the Fund:

- The Fund makes grants to 501(c) (3) public charities (described in Sections 509(a)(1) or (a)(2) of the Internal Revenue Code) that support charitable programs in our focus areas in the United States. The Fund does not make grants to organizations operating outside the United States.
- Grants are made primarily to charities serving our local plant communities (currently Akron, Canton and St. Clair, Ohio, Tryon Peak, South Carolina and Houston, Texas).
- Our primary focus areas include support for programs in the arts, education and community and economic development. The Fund does not provide support or make grants to or for the following:
 - Capital campaigns and projects
 - Political activities/programs
 - Religious activities/programs
 - Individuals in need
 - Organizations other than public charities described in Sections 509(a)(1) or (a)(2) of the Internal Revenue Code
 - Organizations organized and operated outside the United States
- We will consider a limited number of requests from community basic needs organizations; however, our primary support for this focus area is through contributions to United Way.
- Preference is given to organizations that provide the broadest community outcomes aligned with our focus areas and that engage TimkenSteel Corporation associates as volunteers
- Grant submissions are reviewed and approved by the Board of Trustees of the Fund. Consideration of a grant request and the approval or denial of grant requests is in the sole discretion of the Board of Trustees, acting in furtherance of the Fund's charitable mission. Approval of a grant in one year does not guarantee approval of a similar grant request in a subsequent year.
